To date, FOP has made approximately 18 payments for a total of

\$113,760.

d. Costs Assessed: The FOP was ordered to pay \$1.58 per page for the

District's cost of production and has paid the District a total

of \$113,760. The Court granted the FOP's attorney's fees petition, but only awarded the FOP a total of \$53,544.14.

The case was remanded to the Superior Court for additional briefing in light of the decision. Briefing on the fees motions was completed on June 25, 2015, and the parties await a decision from the Judge.
